Washington State Green Building Legislation Sets National Precedent

On April 8, Washington Governor Christine Gregoire signed Senate Bill 5509 into law, making Washington the first state in the country to adopt high performance green building standards for state-funded buildings. Although governors in other states have implemented executive orders relating to green building, Washington's legislature is the first to give high performance building standards the force of law through statute.

Democratic Representative Hans Dunshee worked with Republican Representative Fred Jarrett to spearhead a bi-partisan coalition to pass the bill. Dunshee worked tirelessly for the bill because he believes the law's requirements will mean that "people are going to work in better buildings, and buildings will be better for the communities they are in and the environment around them." Dunshee also expects that "high performance buildings will save money, and in particular high performance schools will help kids do better."

The law requires state agency and higher education buildings (as well as other projects receiving funding in the state capital budget) greater than 5,000 square feet, to be built and certified to the U.S. Green Building Council's Leadership in Energy and Environmental Design (LEED™) Silver Standard. It applies to new construction and major remodels where the cost is greater than 50% of the assessed value. It allows new construction and major remodels of K-12 schools the option of meeting the LEED™ Silver requirement or of using the Washington Sustainable Schools Protocol (WSSP). The WSSP is a set of criteria recently drafted and piloted under the auspices of the Washington State Board of Education and Office of Superintendent of Public Instruction (OSPI). The criteria were initially developed as a voluntary standard due to the initiative of Washington Chapter of the Council of Educational Facility Planners (CEFPI), and of the Northwest Energy Efficiency Alliance, which provided funding to produce the Protocol criteria and documents.

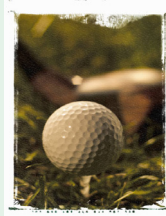
