Keeping it Green-Steps to a Green Cleaning Plan

Whether you have a new building or an existing building, green cleaning is an important way to maintain your asset. I have had multiple opportunities in my 6 years of green building operations with LEED projects to guide the facility staff in creating new or interpreting existing policies; and to develop and implement plans and programs in support of identified green initiatives. Green cleaning done correctly protects the facility, the occupants and the environment.

The following is an overview of recent work with the Senior Maintenance Manager of a local multi-family property developer. My role was to collaborate in the development of a Green Cleaning plan. Here are a few steps that can ease in the plan development and implementation.

Assess the Space Usage - Understanding how the occupants use the space aids in prioritizing the cleaning scope and staffing assignments. In this project, the initial areas of focus were the common areas of the multi-family facility. A matrix was created to identify the surfaces/materials to be cleaned, who will clean them; the frequency, plus who will review the work and how frequently.

Access to current floor plans and interior material specifications shortened the time required to develop the matrix of surfaces. The Senior Maintenance Manager still provided a walk-through of the facility to confirm that materials specified were actually installed.

Set Goals - Consider goals that support the values of your company. As an example, for Customer Services determine a metric, as in a percentage of improvement (20% less calls for cleaning) and set a time (within 6 months of the implementation of the plan). Other goals may relate to the recycled content of the product. With this goal, the recycled content of the paper towels was to be maintained or exceeded. The selected third party verification of Green Seal (GS-01) has the post-consumer content at 50%.

Communication Protocols - Determine means to communicate to all building occupants when a major cleaning is to be completed. This can be through posting of signs, posting on the building website and/or emails to the occupants.

Safety Training - Keeping the building occupants and cleaning staff safe, while minimizing the impact on the environment is a basic of green cleaning. At a minimum, safety training should cover the proper use of protective attire (PPE), e.g. safety goggles worn when handling liquids, the correct lifting procedures and safety features of the equipment, e.g. access to instant stop button for emergency and/or how to ergonomically adjust the equipment to minimize bodily stress.

The correct dilution, application, e.g. spraying the cloth and not the surface can lower costs as less product is used and less airborne particulates released, and the storage of cleaning products is also critical to a safe green operation.

Inventory Cleaning Products, Tools and Equipment - Taking inventory is an opportunity to review whether the existing product, tools and equipment meet the intent of the Green Cleaning plan. This is a good time to identify preferred alternatives that could be used once stock was depleted and/or tools or equipment is due for replacement.

Again, the Senior Maintenance Manager confirmed on his walk through of the facility that equipment, e.g. towel and toilet paper dispensers specified were actually installed. This assured that the product ordered actually was sized correctly for the dispensers.

Be sure to include the products, tools and equipment to be used by outsourced service providers. In the case of the multi-family facility, the contracted deep cleaning services provider had equipment that was due for replacement. The list of preferred equipment helped the provider in their decisions on replacement equipment purchases.

Third Party Verification - A common challenge which applied to this LEED project is that the company was currently contracted to buy from a particular vendor. While the vendor may claim their items are green, it is wise to review which if any of several third party verification programs their products meet. Green Seal, e.g. GS-47, and DfE (EPA Design for the Environment) are two such programs. A third program is the Carpet and Rug Institute (CRI) which rates floor cleaning equipment.

The Ripple Effect - This project provided several unique opportunities to spread the green impact. Upon move-in, the developer/owner provided 6 months worth of green product to the tenant for use in the cleaning of their homes. Survey tools are in place to assess the role this introduction of green product plays in keeping the building green.

When the tenant moves out, the home is cleaned by the green cleaning staff. And, this client is considering implementing Green Cleaning plans at their non-LEED facilities. It is the green that keeps giving.
